Thank you for your interest in serving as a volunteer with Forge Evolution & the Teen Court Program. Please complete the *Adult Volunteer Application, Permission for Press Release, Oath of Confidentiality,* and *Background Check* and return all forms to the Forge Evolution office.

The Teen Court Program meets on scheduled Tuesday afternoons and evenings. Peer Panels begin at 3:45PM and typically run until 6:30PM (you can arrive any time between 3:15-3:45PM). Life Skills classes are held on Monday evenings from 5:00PM to 7:00PM. The level of involvement is up to you as a volunteer and depends on other activities in which you participate. All volunteers are also provided with training materials.

Parking is currently available for volunteers in the BACK HALF of the First Presbyterian Church parking lot on the corner of Bijou & Weber across the street on the east side of the Municipal Courthouse.

A background check conducted by an outside agency <u>IS REQUIRED</u> for all adults volunteering with Forge Evolution & the Teen Court Program. Please fill out the Criminal Records and Background Release form at the end of this application and submit it to Forge Evolution. A fee of \$25.00 must be paid to Forge Evolution when you submit your Adult Volunteer Application and the background check.
