Dear Prospective Student Volunteer,

Thank you for your interest in serving as a **volunteer** with the Forge Evolution-Teen Court program. Please complete the attached **Student Volunteer Application, Volunteer Medical Form, Permission for Press Release, and Oath of Confidentiality** and return those electronically through email or you're more than welcome to mail them or drop them off at Forge Evolution.

The **Teen Court Program** meets for Peer Panels on scheduled **Tuesday afternoons and evenings**. We ask that for Peer Panels our Student Volunteers arrive at 4:30pm with the possibility of court running until 7:45pm depending on our caseload and number of volunteers.

We provide trainings throughout the year for all student volunteers. We do not require you to have already attended training to start serving on **Peer Panels** but we will let you know of upcoming trainings for you to attend. We also allow volunteers to serve on **Trials** with additional training provided by Forge Evolution. We offer *Basic Attorney Training, Advanced Attorney Training, and the Bar Exam*. Which allows student volunteers to serve as Student Attorneys during our Trials.

All **Peer Panels** and **Trials** are held in the courtrooms at the Municipal Courthouse in downtown Colorado Springs located at **244 E. Kiowa Street**. Parking is currently available for volunteers east of the courthouse across N Weber St in the back half of the *First Presbyterian Church* parking lot located on the corner of E Bijou St and N Weber St.

Additionally, for safety and identification purposes, all Forge Evolution Student Volunteers are **required** to wear an official Forge Evolution t-shirt during all Teen Court proceedings. Forge Evolution t-shirts can be purchased for \$10. (small additional fee if paid with card).

We look forward to your participation and involvement. Thank you for choosing to volunteer your time with us here at Forge Evolution-Teen Court. This program would not exist without volunteers like you!

*Forge Evolution is a nonprofit 501(c)(3) organization that empowers youth and fosters resilient communities by inspiring accountability, empathy, and personal growth. The Teen Court Program is one of the pillar programs of Forge Evolution and provides a Restorative Practice alternative to regular court sentencing for first-time misdemeanor juvenile offenders. Although the Teen Court Program works in tandem with the Municipal Court system through Forge Evolution, the organization remains a locally based non-profit that relies on the community support to sustain its programs.*
